Opportunities Abound in the New Year

Well, it's been quite a year at Mass-ALA and as we begin to wrap up 2022, I like to think of the past year as one of transition, new opportunities, and even a transformation, of sorts. We've said goodbye to some colleagues and welcomed others. With each change, as difficult as it may be, comes opportunity; opportunity to learn more about ourselves and each other, opportunity to grow in ways unexpected, and opportunity to improve ourselves and the world around us. The planning of educational events in 2023 provides so many opportunities to explore new ideas and to implement positive changes. As we plan for 2023, we have already set the dates for each module of the program, with all four modules being offered. This training, along with the implementation of quality assurance measures, can be an effective tool to help assisted living residences to prepare for recertification surveys by the Massachusetts Executive Office of Elder Affairs.

As you consider registering for one – or all – of these modules, I'd like to suggest that you attend Boot Camp as a precursor. Taking Boot Camp prior to the QA/QI Training will enable participants to have a basic understanding of the operations of an assisted living community and will provide a framework upon which to build the details of QA/QI. Where Boot Camp leaves off

in providing an extensive overview of important operational information, the Quality Assurance/Quality Improvement Training Program will pick up and provide the details in a systematic approach that will be relevant, easy to follow, and immediately applicable to the operation of an assisted living residence. In **2023**, **Boot Camp** will be offered **virtually** on the dates listed below.

February 16th May 18th August 17th November 16th

We've had an interesting year in that we began to transition from all virtual educational events (due to the pandemic) to some remaining virtual and back to some being held in person. In planning for the 2023 education calendar, we have decided to continue with Regulations Training and the Annual Conference being held in person, along with the Awards Dinner; however, other trainings will be offered utilizing a virtual format for the coming year. One of those trainings to be offered in the early part of 2023 will be a webinar to be held on February 21st, which will be "The State of Falls and Criteria for Evidence-Based Programs." This will be presented at 10:00 a.m. with the details regarding the ending time still being finalized, but it will be roughly 60 – 90 minutes in duration. Stay tuned for more details about this webinar coming soon.

The committee shall assist in developing educational content for trainings, focused on providing high-quality learning for management and staff working in assisted living. This committee has six meeting per year, with each meeting lasting approximately 90 minutes.
